3. **SETUP** Client shall ensure that the room or area designated for the performance will be available and open at least 1 HOUR before the above listed starting time.
5. **SECURITY** Client shall provide any security needed to ensure a safe environment for Performer. Client also assumes full responsibility for any equipment damage by guests or patrons of the Client.
6. **OVERTIME** Performer cannot guarantee the availability of services past the contracted time. Overtime, if available, charged at \$\_\_\_\_ per hour.
7. **CANCELATION** If for any reason specific Performer named above cannot perform at your event, Performer will not be responsible for any other penalties, charges or reimbursements.
